<b>Disclosable Pecuniary Interests</b>	
<b>1. Employment, Office, Trade, Profession or Vocation</b>

You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and <b>either</b> the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, <b>or</b> one hundredth of the total issued share capital of any class of shares issued.	none
