<p>Ref: 20/02136/TPO - Fell Sycamore tree 'T2' protected by Tree Preservation Order no.14/1996 at 3 Fox Garth.</p>	<p>The Parish Council decision was C. We do not like to see trees removed and certainly not those with TPOs and which are not proposed to be replaced but here we believe there are strong reasons in favour of allowing the application:</p> <ol style="list-style-type: none"> 1. The trees in question by root damage are causing the undermining of the foundations to a boundary wall. 2. The roots are also lifting the brick paved driveway of a neighbouring property. 3. This damage to a neighbour's property is not supported by the NPPF 4. The trees being sycamore are not particularly valued 5. Pollarding will not solve the issue as the damage is being created by the roots not the trunk or branches 6. This tree needs to be removed.
