It was noted that the Local Planning Authority had approved the following applications: -

- Ref: 21/01397/ADV Display of 2no. internally illuminated fascia signs, LED lighting strips within cladding joints to eastern elevation of building and 1no. internally illuminated pylon sign to Ings Lane at Ray Chapman Motors, Ings Lane.
- Ref: 21/01569/FUL Variation of condition 2 of permitted application 20/01838/FUL to alter location of substation and staff and service car parking on the Ings Way/White Rose Way corner by Ray Chapman Motors, Ings Lane.
- Ref: 21/01590/TPO Crown thin Sycamore by up to 20%; reduce lateral limb by no more than 2m protected by Tree Preservation Order no. 1/1970 at 5 Church Lane.
- Ref: 21/01625/TPO Prune back limbs from 1no. Sycamore touching the house roof; remove epicormic growth from 1no. Sycamore; crown reduce 1no. Sycamore by 20% protected by Tree Preservation Order no. 1/1970 at Sandham House, Main Street.
- Ref: 21/01684/FUL Single-storey rear extension after demolition of existing conservatory and raise roof height and make alterations to existing garage at Craigiera, 3 Hallgarth Close.
