*(a) To consider the following Planning Applications*

Details of Planning Applications	Comments
Ref: 22/02035/TCA - Fell 2no. Cherry trees in a Conservation Area at 28 Church Lane, YO26 6LB.	<b>The Parish Council decision was D. The planning application does not indicate where the trees are located. There is an obvious Cherry Tree on the verge in front of the property. It was felt that this should remain as it is in good health.</b>
Ref: 22/02119/TPO - Fell 1no. Scots Pine protected by Tree Preservation Order no. CYC286 at 12 Church Lane, YO26 6LB.	<b>The Parish Council decision was B. It is recognized that there is a TPO on the tree but the Council felt it would be hazardous to life and property if it fell down.</b>

*(b) To note Local Authority Planning Decisions*

It was noted that the Local Planning Authority had approved the following applications: -

- Ref: 22/00249/FUL - Detached garden pod with decking to rear (retrospective) at Town Farmhouse, 25 Church Lane.
- Ref: 22/00930/FUL – Single-storey rear extension, 2no. roof lights and dormer to rear at 4 Church Lane.

It was noted that the Local Planning Authority had refused the following application: -

- Ref: 22/01039/FUL – Single-storey rear extension at 3 Linton Road.

*(c) To discuss the Lord Nelson decision from the Planning Inspectorate*

A lengthy discussion took place on the Appeal Decision by the Planning Inspectorate. It was noted that the property to the rear of the Lord Nelson on Plot 2 is now up for sale based on the planning permission for the planned house. If the purchaser changed the plan then it would again come before the Council and Parish Planning Committee. It was also noted that the Lord Nelson Pub under new ownership is thriving and it is hoped that this will continue although parking is now restricted.

Cllr. Harper reported that a meeting has now been arranged with Historic England and the City Council Conservation officer. It is hoped to progress the work that has already been consulted upon.
