 The Councillors were concerned about the volume of traffic generated by the Northminster Business Park and recommend that a different access route, other than Northfield Lane, be constructed. It was suggested that this recommendation be sent to the City Council for their consideration. It was to give some respite to the residents in Northfields Lane from the vastly increased traffic noise which would increase exponentially if DPD expand their delivery service with HGVs using the lane during the night. It was further agreed that no planning approvals should

be allowed until a new access road had been constructed ideally from the A59 at the western end of the park and ride site.
