MINUTES OF THE PARISH COUNCIL MEETING HELD IN THE POPPLETON CENTRE, UPPER POPPLETON, AT 7.15 PM ON MONDAY, 18 SEPTEMBER 2023

23/249 - TO CONSIDER THE APPROVAL OF REASONS GIVEN FOR ABSENCE

23/250 - TO CONFIRM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 21 AUGUST 2023

The minutes of the Parish Council meeting held on 21 August 2023, having been circulated prior to the meeting, were approved and signed.

23/251 - TO RECEIVE A REPORT FROM A CITY OF YORK COUNCILLOR

City Cllr. Anne Hook reported: -

Reductions to the speed limit to 40mph on the A59 to beyond the Red Lion, and Hodgson Lane and Black Dike Lane from the A59 to the 30mph limit have been approved at the last decision meeting of the Executive for Economy, Place and Transport.

Yellow lines on Ebor Way near the junction of Millfield Lane will now go to consultation and the zigzags in front of the school are going to become compulsory instead of advisory.

The request for a reduction to the speed limit on Northfield Lane has been refused, so press articles are being written. I have been investigating improving the signage to prevent vehicles overshooting Northminster Business Park. The sign cannot be seen until just 30 from the entrance, so given stopping speeds, it is little wonder that vehicles often overshoot, putting walkers and cyclists in danger by day and waking nearby residents by night. Apparently there used to be larger signs, paid for by Northminster and installed by CYC, but then CYC removed them. Northminster were not happy about this either.

Generally, you will have heard press reports about a predicted overspend of millions which has resulted in cuts to some important items of expenditure. There is always a significant predicted overspend at this time of year but it always seems to right itself - e.g. delays in recruitment, not having resources to carry out forecast spend. We therefore believe the cuts are premature and harmful and are fighting them.

23/252 - TO RECEIVE THE CLERK'S REPORT ON PROGRESS ON THE FOLLOWING: -

- (a) Making the Long Ridge Lane/Millfield Lane junction more cycle friendly (Min. 23/222a) No news on this subject.
- (b) Pruning back the branches of trees overhanging Somercote (Min. 23/222b) It was noted that the branches are to be cut back on 25 September.
- (c) Felling a dead sycamore by Riverside Walk (Min. 23/224bi) It was noted that the sycamore has been felled.
- (d) Removing ivy from the end wall of the cartshed (Min. 23/224f(iii)) Cllr. Jones reported that the ivy had been severed at the base. It was agreed that it would be easier to remove the ivy from the wall when it was completely dead.
- (e) Lining the underside of the roof in two of the cartshed bays (Min. 23/224f(iv)) It was noted that the work has been completed.
- (f) Removing the tall bush in the planter at the corner of Ebor Way and Allerton Drive (Min. 23/226b)

It was noted that the bush had been removed.

It was agreed that the Clerk ask Ken Falkingham if he would spread the chippings from the felled sycamore along the path through Warren Lea. (Action Clerk)

- (c) The management of the Common Land including
- i. Progressing the rectification of the damage to the riverbank next to Saxe Dane Lodge The Clerk reported that the owner of Saxe Dane Lodge had agreed to the Parish Council's proposal to plant willows in the riverbank. Permission from the Environment Agency must now be given for the work to be done. The Clerk is writing to the EA to ask for said permission. (Action Clerk)
- *ii.* To consider quotations for conducting the five-year tree survey
 Two quotations for the work were considered. The Cllrs. resolved to accept that from Tree Care
 Consultancy. (Action Clerk)
- *iii.* To agree pollarding two of the riverbank willows to allow a view of the Ouse upstream Two quotations for the work were considered. It was resolved that the Ryland Horticulture quotation be accepted. (**Action Clerk**)
- (d) Allerton Drive garden

It was agreed to accept a quotation for clearing out the weeds and sycamores from the bottom of the hedge. (Action Clerk)

(e) The Moat Fields

The Moat Fields Management Group had asked the Parish Council if it would support the installation of a ramp to the existing access between the Moat Fields and the Millennium Green. It was agreed to support the scheme but to make sure that handrails would be installed at each side of the ramp. The cost is to be borne by the Moat Fields Management Group. (Action Clerk)

- (f) The Cartsheds including
 - i. Progress on the application for a Street Works Section 171 Licence for laying asphalt in front of the cartsheds

It was reported that the City Council has granted a Section 171 licence and that the work is to be carried out on the 6^{th} and 7^{th} of October.

- ii. To consider repairing the underlining of the roof in the right-hand cartshed bay It was agreed not to have the underlining repaired for the time being but to continue to monitor the situation.
