City Councillor Anne Hook reported that the Rural England Prosperity Fund is offering capital grants for community buildings in our Ward.

24.048 - PUBLIC PARTICIPATION

Councillor Jones, a Nether Poppleton Parish Councillor, briefed Councillors about the proposed improvement, by Yorkshire Water, to the sewage pumping station by the beck in Nether Poppleton. The development will help reduce the incidents of sewage being spilled into the river in extreme rainy conditions. It will necessitate the provision of a holding tank in the farmer's field, drainage over Parish Council-owned land and the removal of five trees. She was at pains to explain that the project did NOT indicate that any houses would be built in the area.
